HOST SITE AGREES TO:

- Appoint an individual to be the primary contact. This individual will work with the Special Programs Coordinator to accomplish all the agreements listed in this document.
- Ensure that all leftover product will either be distributed to a Feeding America Eastern Wisconsin member or returned to a Feeding America Eastern Wisconsin warehouse.
- Accept that product is occasionally damaged during transportation, sorting or storage. Feeding America Eastern Wisconsin will inspect the product and determine if it can be distributed or must be disposed of.
- Distribute the product as soon as possible and maintain enough refrigeration and storage space to ensure the safety of the product.
- Distribute food and products free of charge and without direct solicitations for donations from clients.
- Use the items solely for the feeding of people in need, infants, or the ill.
- Not engage in discrimination, in the provision of service, against any persons because of race, color, citizenship, religion, sex, national origin, ancestry, age, marital status, disability, sexual orientation, including gender identity, unfavorable discharge from military or status as a protected veteran.
- Communicate feedback to Feeding America Eastern Wisconsin promptly following the special program.
- Willingness to abide by the policies, procedures, and record-keeping requirements of Feeding America Eastern Wisconsin.
- Willingness to adhere to additional stipulations as required.
